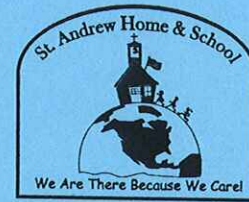


**St. Andrew Home and School**  
 SCRIP Enrollment Form 2010-11  
 (disbursements Beginning July 2011)



**Program rules and guidelines:**

1. The Scrip year is May 1 through April 30. You may change your rebate designation at the beginning of a Scrip year.
2. One half of the rebates from the Scrip Program will be retained by the St. Andrew Home and School Association and one half can be designated on the enrollment form below. Rebate designations can be made to: St. Andrew Tuition (a specific family), Catholic High School Tuition (a specific family and high school), Parish School of Religion (a specific family), St. Andrew PreSchool (a specific family).
3. Designated rebates cannot be redeemed for cash.
4. Your share of the rebates earned during the Scrip year will be applied to your tuition/fees beginning in July of the subsequent year. (i.e. earnings thru 4/30/2011 will be applied to 2011-2012 tuition.) Due to administrative costs, we will not apply a rebate if the total earned by the family is less than \$10 for the scrip year.
5. Rebates are non-refundable. Rebates earned in excess of total tuition or fees due will not be paid out in cash or credited towards a second designation.
6. Cash or check must accompany all Scrip orders unless prior arrangements have been made for payment. Orders made on [www.shopwithscrip.com](http://www.shopwithscrip.com) may be paid with PrestoPay (debit transaction). Checks should be made payable to St. Andrew Home & School – Scrip.
7. Scrip payments are **not tax deductible** as you receive dollar for dollar value for your purchases.
8. If your check is returned due to insufficient funds (NSF), you will be charged any related bank fees. After two NSF checks, your Scrip privileges will be limited to PrestoPay or cash.
9. St. Andrew Home & School – Scrip will provide a bi-annual summary of rebates earned for each participating family. Reports will be issued for periods ending in October and April.
10. When you pick up your Scrip order, open and verify its accuracy. Please contact one of the committee chairs immediately if there is a discrepancy. All orders are checked twice for accuracy, but errors may occur.
11. All sales are final.
12. Scrip cards are the same as cash and should be handled accordingly. St. Andrew Home & School will not be responsible for certificates which are lost, stolen or misplaced after delivery to you.
